The contest will begin Saturday April 1, 2017 at 3:00:00 p.m. MST and will end Saturday April 15, 2017 at 11:59:59 pm MST.

Winner will be selected Monday April 17, 2017 MST

Notification attempts will begin April 17, 2017 MST

2. ELIGIBILITY TO ENTER:

This contest is only open to residents of Canada.

This contest is in no way sponsored, endorsed, administered by, or associated with Facebook. Facebook can not be held liable for anything relating to this contest.
